HE Dr Frank-Walter Steinmeier

President of the Federal Republic of Germany

Dr Frank-Walter Steinmeier was elected as the twelfth President of the Federal Republic of Germany on 12 February 2017.

He served as Head of the Federal Chancellery from 1999 to 2005. Steinmeier was appointed Federal Minister for Foreign Affairs in 2005 and was also Deputy Chancellor from 2007 to 2009. Four years later, he became Federal Minister for Foreign Affairs for the second time, and served in this role until January 2017.

HE Macky Sall

President of the Republic of Senegal

Elected fourth President of the Republic of Senegal, Macky Sall was sworn into office on 2 April 2012. On 24 February 2019, President Sall was re-elected for a second five-year term of office (2019 – 2024).

On being sworn in for his second term on 2 April 2019, President Sall again called for inclusive, constructive and open dialogue on all the major factors affecting the country, including political, economic and social issues.
